## INCLUSIONS

## FEEDING GUIDE

- Feed as part of a balanced diet
- These pellets have a high grain content so must not be fed to hungry stock
- Rangeland Weaner Pellets should be introduced over a 3-5 day period using hay or another form of fibre as a supplement
- Avoid any interruptions to the daily feeding pattern. If interruptions occur, re-introduce slowly.
- Ensure fresh, clean water is always available

## RECOMMENDED INTAKE

The recommended intake of this product should be **up to 3% of live weight daily.**

Adjust rate according to growth stage and pasture availability.

## STORAGE INSTRUCTIONS

Store in dry cool and clean place. When stored under correct conditions best before 12 months from packing date.
